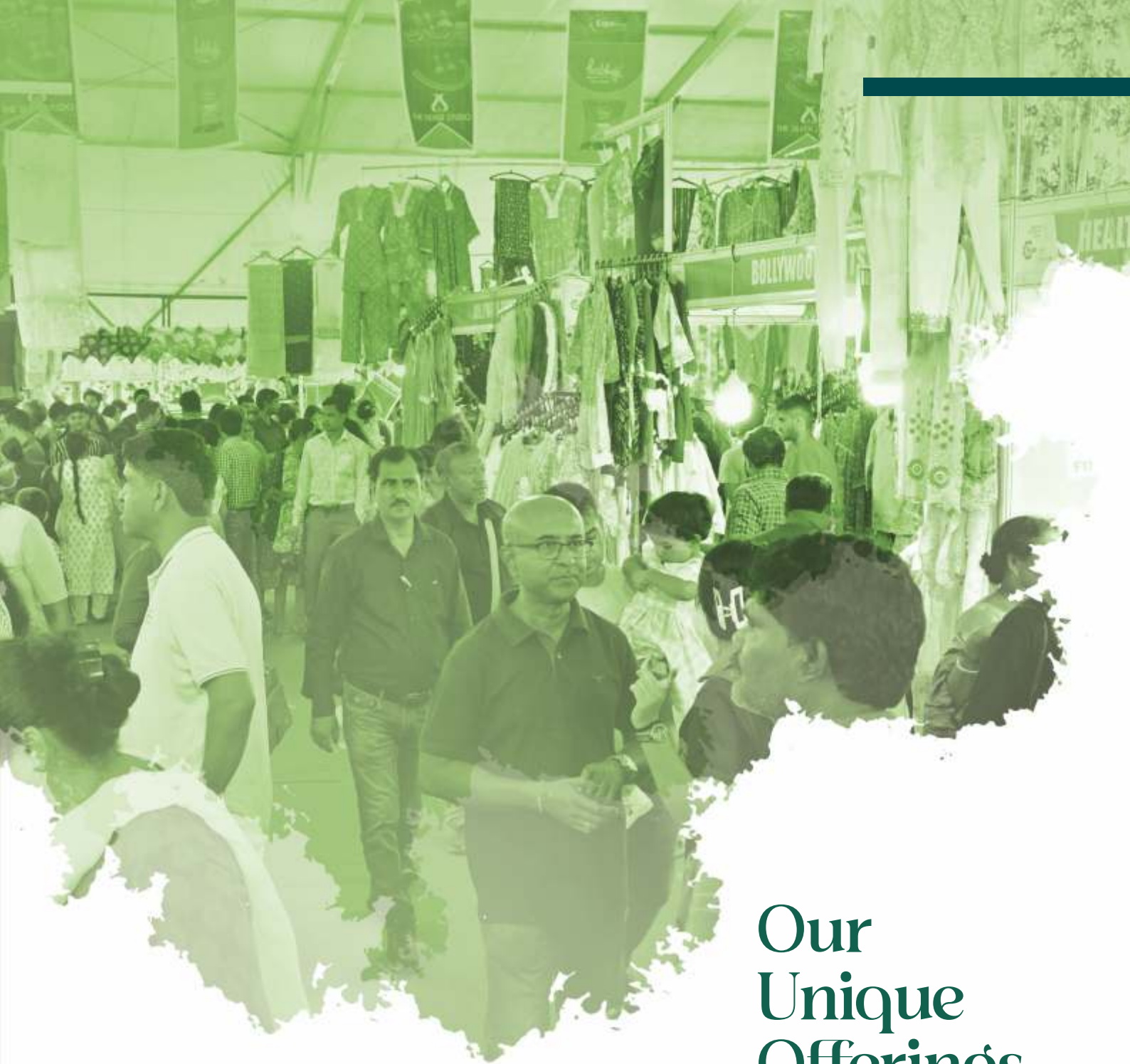

Submit application form with advance payment within due date for booking.

03

Allotment of stalls will be generally done on first cum first serve basis.

04

The details of allotment will be communicated to the exhibitor by 14th Sept. 2025

STANDARD FACILITIES

Stall charges includes the following :

- Hire charges for Stall, Facia with Exhibitors Name
- Two (2) Chair
- One (01) Display Table
- One (01) Tent Table
- Carpet Flooring
- Electricity supply with 1 KW with three spot light and one 5 Amp point
- Mineral Water and Food Coupon (As fixed by organizers)
- Common Public Address System
- Six (06) Exhibitor Passes for every stall. Passes can be collected from JCI Reception Office from 1 p.m. to 3 p.m. on the inauguration day

Other additional requirements are chargeable and shall be provided by the organizers only if possible.

SECURITY

General Security will be provided Round the Clock in the premises from Inauguration Ceremony to Closing Ceremony of the Expo Utsav.

However, the organizers will not be responsible for any theft, loss and damage to any property of exhibitors.



FIRE FIGHTING EQUIPMENTS

Fire Fighting Equipments will be provided at different points of the Exhibition premises. Exhibitors are however advised to take due precaution and keep necessary Fire Fighting Equipments in their stalls on their own. The organizers will not be responsible in any case for any kind of damage that may be caused due to fire.

INSURANCE

Exhibitors are advised to ensure their exhibits and other material personally, by themselves. The organizers will not be responsible for any pilferage, theft or tampering etc.



SAMVAD KENDRA

A Helpdesk cum Information Centre will be setup at the premises site for the benefits of the visitors and exhibitors to disseminate information about the exhibition and services.

- **Standies and Posters** : Standee and Posters of EXPO are displayed in Movie halls, Parks, Clubs, boutiques, malls, apartments and other public areas to aware consumers.
- **Dignitaries and Invitees** : Prominent personalities are invited and their visits at EXPO, graces the feel and publicity of EXPO .
- **Bike Rally** : Expo becomes the talk of the town when a massive bike rally is organized to mark its beginning before the inauguration.
- **Gates** : Welcome gates will be made at the venue.
- **Stage Events** : Various stage events would be organized for the students / visitors at the venue.



- **Press Conference** : To aware with the details of the exhibition, press conference shall be held by the organizers from time to time.
- **Training & Workshop** : The basic objective of EXPO is to promote entrepreneurship and aware consumers, hence in EXPO '25 there can be training workshops to promote entrepreneurship, self employment and business, so hundreds of students from different colleges & +2 schools will keep visiting the EXPO throughout the seven days.

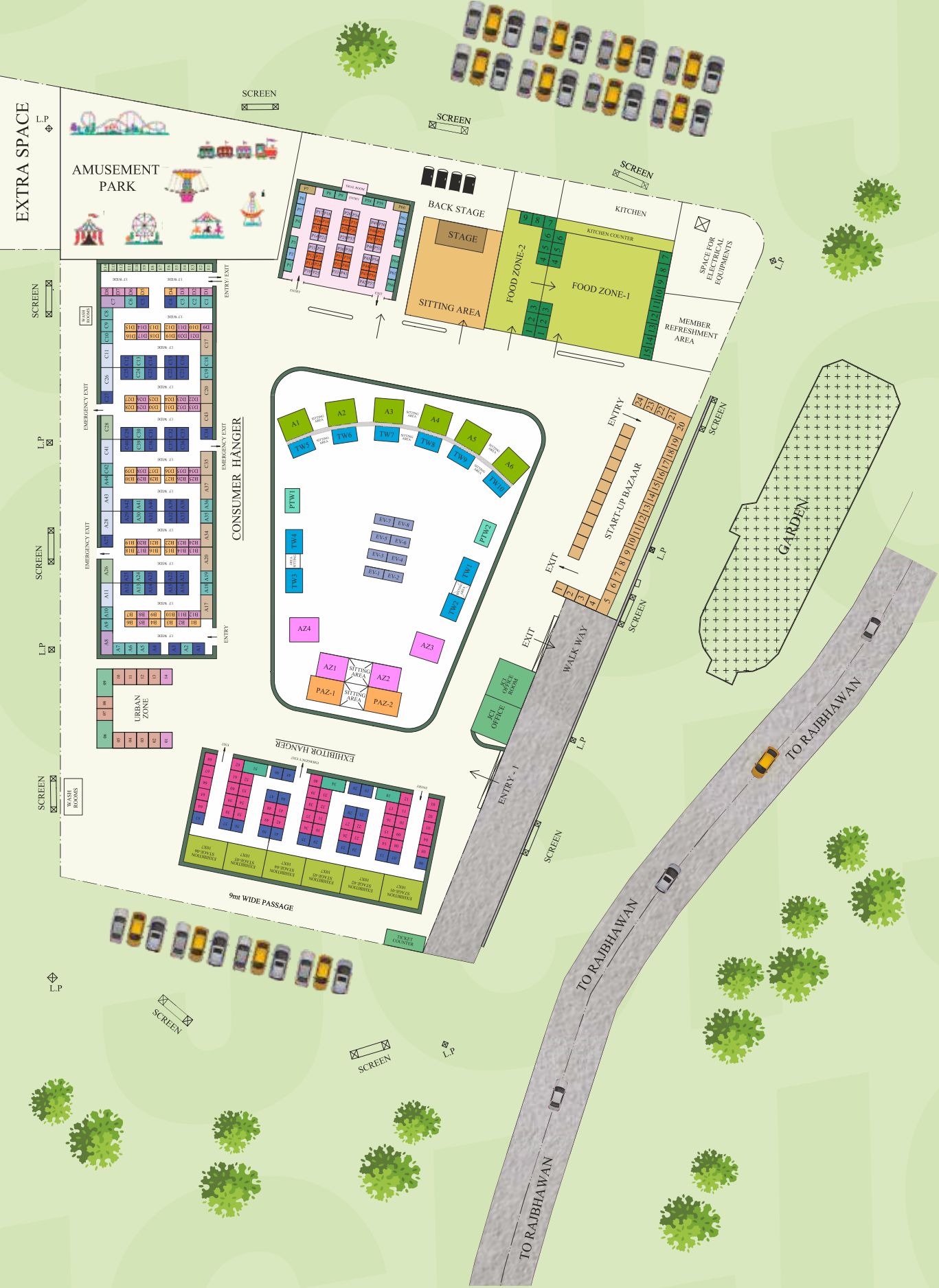

TERMS & CONDITIONS

1. All participants should ensure to make full payment at the time of booking the stall. Allotment of stalls will be done by the organizers. Organising Committee reserves the right to change/cancel the stall location allotted to the participants.
2. The transportation related to Expo materials will be allowed to be taken inside the expo premises only till 8 pm on 15th of September 2025. The premises must be vacated by 8:00 pm, 22nd September 2025.
3. Exhibitors or Participants should collect their Expo Badges, Kit & give Additional Requirements if any, latest by 6:00 PM, 16th September 2025 to JCI helpdesk counter.
4. No exemption/approval given by the Organisers will be effective unless in e-mail (jciexpoutsav@gmail.com).
5. The stall allotted to exhibitors are meant only for display and demonstration of products. No sales can be made from the stall.
6. Exhibitors or Participants will ensure the security and safety of their exhibits against any kind of loss, damage, theft, fire or other whatsoever. It is the responsibility of the Exhibitor to ensure that it maintains insurance to cover its losses or liabilities arising out of or in connection with the Expo including: (i) insurance of the Exhibitor's property; (ii) liability for injury sustained by employees or third parties. (iii) liability for loss or destruction of or damage to property of the Venue, the Organisers and any third party; and (iv) insurance against losses arising out of the cancellation of the Expo due to causes beyond the control of the Organisers
